Cllr Cole welcomed everyone and explained that he had received a late planning application that he would declare as 'urgent' His reasons were that after this evenings meeting, the next public meeting would not be until September (and any response would be outside the consultation deadline) and that the Planning & Development working group had agreed the application would not be contentious. 044/2024 **Public Participation.**

Cornwall Councillor Phil Seeva sent a written report, that: at full council on 16 July 2024, unanimous vote to support a fairer funding deal for Cornwall and for lobbying the new Prime Minister; looking forward to meeting the newly-elected MP; Leader of the Council, Cllr Linda Taylor is touring the division on 2 August and asks that any issues that need raising with her should be notified in advance; North Treviddo appeal will now be determined by written representations following a site visit – decision expected in August.

Progress report on the council's response to the 5 Day Protocol for Tencreek Farm Application: PA22/03642

Proposal: Full planning for the erection of 202 dwellings and associated works Location: Land At Tencreek Farm, Plymouth Road, Liskeard, Cornwall PL14 3PS

Cllr Cole reported that no decision had yet been made, and referred councillors to an opportunity to question officers from South West Water next week about discharges into the River Seaton. *Action: Clerk to forward Chair's proposed questions. Any replies needed before 22 July 2024.*

Chair referenced earlier planning application PA24/02518 (Alteration, conversion and extension to form a dwelling and integral garage on land adjacent to Minefield Cottages) and noted that groundworks appear to have started on land to the rear of the site. Previous concerns around potential breaches of planning conditions were noted.

Action: Clerk to recirculate planning officer's decision and conditions for information.

049/2024 Chairs Report

A Civility & Respect Pledge

It was **Resolved to adopt the pledge**. Proposed Cllr Easterbrook. Seconded Cllr Cole. All agreed. Councillors agreed that it will treat councillors, clerks, employees, members of the public, and representatives of partner organisations and volunteers with civility and respect in their roles according to the published statement.

Action: Clerk to publish pledge and circulate supporting documents.

B Community Area Partnership

Reported back from the 9 July 2024 meeting with key items being a strategic delivery programme that would scrutinise the future of Tamar Crossings (Tamar 2050) and a consultation of a proposed Draft Housing Decarbonisation Strategy. Chair asked that the Planning & Development working group agree a response to the decarbonisation strategy and submit it on behalf of the parish council, conclusions to be endorsed at the September meeting. Cornwall Cllr Hilary Frank (Saltash Essa) was elected vice-chair of the CAP for 2024/25.

Action: Clerk to circulate Decarbonisation Strategy for comment to P&D group...

C New dog bin for Lower Clicker

It was **Resolved to postpone a decision on the installation of a new waste bin.** Proposed Cllr Cole. Seconded Cllr Easterbrook. All agreed. Councillors noted the request for a new bin from a resident, but because of the low number of people responding to a survey of need and location (three received) agreed to postpone their decision in order to give residents further opportunities to feedback.

Action: Clerk to add to February 2025 agenda.

D Parish noticeboard for Menheniot Village

Chair updated councillors on progress towards replacing the current ageing noticeboards by the Spar shop in Menheniot village. In order to install new boards, council will either need consent from the house owner (if attached to the wall) or Cornwall Council (if attached to posts). Pending consent from either party, it was **Resolved to agree purchase** of two noticeboards, and allocate a budget up to £1600net. Proposed Cllr Easterbrook. Seconded Cllr Goldsmith. All agreed. Purchase will only be made once agreement has been reached on the fixing of the boards and with prior notice to councillors.

Action: Chair to continue discussions with house owner and Cornwall Council.

E Merrymeet Speed Warning Signs

The Community Area Partnership has agreed to allocate £16,500 to purchase and install a single speed warning sign, and be asked to fund an additional sign from the general reserve. Following a meeting between the Community Area Partnership and CC Highways, a decision was made to fund one single sign and to consult with the parish council on its final location. It was **Resolved to ask for the new sign to be located** on the approach to the turnoff into Merrymeet in the direction towards Liskeard. Proposed Cllr Cole. Seconded Cllr Luck. All agreed. Councillors asked that the Chair should meet with the CC Portfolio holder for Transport to negotiate funding for a second warning sign on the opposite side of the road.

Action: Clerk to feed back to CAP officer and agree an agenda for a meeting between Cllr Phil Seeva, Cllr Cole and the Portfolio holder for Transport.

A new ceiling in the main hall will be installed during 5-31 August. It was Resolved to agree to fund the cost (£348) from General Maintenance for materials, slabs, sand and cement for paving at the rear, provided a suitable sub base to receive the slabs with appropriate materials is constructed. Proposed Cllr Cole. Seconded Cllr Tucker. All agreed.
