### **030/2024 Members' Declarations.**

No declarations made or dispensations requested.

### **031/2024 Public Participation.**

Cornwall Councillor Phil Seeva reported that: CC had held its annual meeting on 21 May and elected Cllr Pauline Giles as Chair of the Council, and Cllr Linda Taylor as Leader; his Community Chest is now open for grants; noted the planning officer's proposed decision for the development at Tencreek Farm and was supportive of his recommendation. There followed a discussion with Cllr Smith about continuing concerns about speeding vehicles at Merrymeet, and residents' disappointment at the lack of progress to install speed warning signs. The full cost of the signs (including purchase and installation) was now estimated at approximately £30,000 which would exceed to local budget for road safety measures. Cllr Seeva noted that police records did not evidence any local fatalities since January 2020, and this was a critical factor in determining any safety installations.

*Action: Cllr Seeva will set up a meeting with CC Richard Williams-Pears (Cabinet Member for Transport) to discuss what may be done, including the option of the parish council purchasing a speed warning device.*

### 036/2024 Councillors Report

#### A Cllr Keith Goldsmith

Almost 30 planted half-barrels of plants have been distributed across the parish in preparation for the judges visit on 23 July for the South West in Bloom Best Village Competition. The councillor asked the Chair to write a letter of thanks to the landlord of The White Hart to acknowledge his extensive planting around the public house. Cllr Ball offered to remove waste soil and weeds from the village green. The National Garden Scheme will see 10 gardens open in Menheniot this Sunday 23 June. Cllr Goldsmith asked residents and councillors to support the scheme and thanked everyone involved for their hard work.

#### B Cllr Peter Luck

The new Menheniot Community Speedwatch group held its first session at Mine Hill on 4 June 2024 and recorded 13 vehicles using the road between 08.30 and 09.30. Most vehicles were within

the speed limit but one road user was recorded as driving at 44mph (speed limit is 30mph) and has been reported to local police for follow up action.

C Cllr Steve Roberts

A meeting with Menheniot Primary School about road safety on East Road was held on the afternoon of 20 June attended by Cllr Roberts and Luck, together with representatives from the school. Cllr Roberts reported that the meeting had been very productive and there were practical measures that could be implemented very soon.

*Action: Clerk to organise a Zoom meeting with Cllrs Roberts, Luck and Cole to debrief and publish their findings.*

D Cllr Pat Cade

The Friday community bus service running between Menheniot and Liskeard continues to be well used with more passengers wanting to use the service that can be accommodated on board. The Wednesday service (via Saltash) is much less popular. The bus operator (Saltash Red Bus) is meeting with Cornwall Council next week and will negotiate for additional capacity for the Friday service.

*Action: Clerk to contact SRB for updated information on negotiations.*

C Cllr Tony Ball

Council has received the RoSPA report of its annual inspection of playgrounds at Menheniot and Merrymeet and reported that: several wooden fencing posts at Merrymeet need replacing; grab handles on some items will need repainting and the wooden play equipment needs cleaning. In Menheniot, several items need minor repairs and repainting. None of the play equipment has been assessed as being in urgent need of repair.

*Action: Clerk to visit play areas with Cllr Ball to photograph equipment and agree a repair schedule, obtain a quotation for repainting. Cllr Cole will speak with contractors about restoring grassed area at the rear of Menheniot parish hall.*
