#### 053/2024 Chairman's Welcome.

In the absence of Cllr Cole, Cllr Easterbrook took the Chair for this public meeting.

#### 054/2024 Apologies for Absence.

Received from Cllrs Cole, Berg, Ball and Smith.

## 055/2024 Members' Declarations.

No declarations made or dispensations requested.

#### 056/2024 Public Participation.

Cornwall Councillor Phil Seeva reported that the enforcement appeal for a property at North Treviddo had been rejected and the planning inspector had granted a 12 month period for compliance. Progress towards compliance will be monitored by Planning Officers. A further enforcement matter at Merrymeet had resulted in a visit from planning officer to the property - the occupier has been served a notice and has 21 days in which to respond to the officer's concerns. Due to the continuing absence of an adjacent divisional member, Cllr Seeva will be taking on casework from three other parishes in addition to the five he currently covers. He reminds the meeting that divisional councillors are not salaried but receive an allowance from Cornwall Council to cover necessary expenses, details of which can be found on the Council's website.

It was **Resolved to support** the application. Proposed Cllr Easterbrook. Seconded Cllr Goldsmith. All agreed. Councillors agreed that there were no relevant material considerations that would prevent their approval.

All agreed and asked that Cornwall Planners should be satisfied that the materials used are sympathetic to the setting (this in the response to a request from the Historic Environment Planning Team); that officers note concerns about overlooking from the stairwell, and a construction management plan to regulate the movement of vehicles into the site is agreed.

D Tencreek Farm

Progress report discussions with Cornwall Planning Officer

Application: PA22/03642

Proposal: Full planning for the erection of 202 dwellings and associated works

Location: Land At Tencreek Farm, Plymouth Road, Liskeard, Cornwall PL14 3PS Cllr Easterbrook reported that during a meeting with the responsible Planning Officer on 2 September, he clarified that the current Masterplan would be used to inform any future applications [for employment space] and the parish council would be consulted in the usual way; noted concerns from residents about provision for increased healthcare, education and highways; encouraged the parish council to draft proposals for play area/open space as soon as possible (there may be competing bids). Councillors briefly discussed the potential impact of an increase in residents in the parish arising from this development and will consider how to work with both the builder and local community to integrate them into the parish.

#### E Enforcement

Update: A Hearing will not take place and the appeal is to be decided on the basis of an exchange of written statements already submitted by the parties and a site visit by an Inspector. Breach of Planning Control: Appeal against Enforcement Notice - Without planning permission, the material change of use of agricultural land to a mixed use comprising of agricultural and residential through the stationing of residential caravans with associated operational development including the creation of a residential chalet, hard standing area, shower/toilet unit and raised wooden decking. Also, the agricultural building approved under PA19/05798 is being used for the storage of non-agricultural paraphernalia.

Following a request from Wainhomes and Cornwall Council, the parish council has consulted on suggestions for street names at Tencreek Farm. 45 suggestions were received, and after filtering to remove those that did not comply with planning regulation, the remaining 16 names were passed to Wainhomes. The Chair thanked everyone who had taken part.
