114/2024 Chair's Welcome and opening remarks.

115/2024 Apologies for Absence.

Apologies received from Cllrs Tucker and Cade. Also from Parish Clerk, John Hesketh.

116/2024 Members' Declarations.

Cllr Hemming declared an interest in Item 119/2024D. No other declarations of interest or request dispensations requested.

117/2024 Public Participation.

A representative from the Merrymeet & Pengover Green Residents Association attended to ask about the inclusion of Merrymeet in consultations on S106 funding arising from the development at Tencreek Farm. The Chair explained that consultations would be made at the appropriate time and that funding will be paid in two instalments. The first instalment will be prior to Occupation of 50% of the Market Dwellings and the remaining 50% prior to the Occupation of 75% of the market dwellings¹. However, the council welcomes discussions on potential uses, including the potential for improving and upgrading current outdoor recreational facilities at East Road Playing Fields.

Cornwall Councillor Phil Seeva reported that: full council had signed off on a 4.99% increase in council tax at its meeting on 25 February 2025, in line with many other unitary councils; the level of debt that CC carries (£1.3bn) may appear high but around 25% of that is actually 'investment debt' that generates an additional income for the council (the council borrows at a low rate of interest and lends it back out at a higher rate, creating a revenue); the last full meeting of CC takes place on 15 April, two weeks before the 1 May county and parish elections; it is his intention to stand again as the divisional member for St Cleer & Menheniot; the current planning enforcement site in Merrymeet was visited by CC officers yesterday and he is unable to comment at the moment; will follow up complaints that the newly installed speed warning signs at Merrymeet do not function until approaching vehicles reach 65mph; has discussed planning application PA25/00675 with CC officers and will support calling it in to the planning committee (see Item 119/2024D below).
