# 026/2025 Public Participation.

Cornwall Councillor Sean Smith reported that: has made enquiries about the introduction of the new 20mph speed limit in parts of the parish, and expects this to be implemented in June/July; has approached CC Highways to reinstate road markings outside of Menheniot Primary School and will ask about extending the parking limits to lower Mine Hill (CC Highways have confirmed this is in their current workplan). Has raised issues with CC Planning Officers about: ground contamination (retrospective planning application PA25/02746); part discharge of planning conditions at PA25/03162 (Merrymeet); following up PA25/00675 (Land south-east of Roseland House) which he asked to be called-in to the planning committee; PA24/06937 (Tencreek Farm) that measurements of flood risk were not satisfactory.

It was **Resolved to endorse the previous decision**. Proposed Cllr Smith. Seconded Cllr Cole. All agreed.

Action: Clerk to inform CC Planning Officer. CC Cllr Smith will ask that officers scrutinise any further planning applications for this site with regard to ongoing concerns about ground contamination.

The Chair declared that this was an item of urgency and would be considered at this meeting. **PA25/01893** 

Proposal: The conversion of an existing barn into a 2 bedroom dwelling compliant with Policy 7.3. Location: Treweatha Barn Merrymeet Liskeard Cornwall PL14 3LS

Councillors reviewed their previous decision to not support and the planning officer's response. Decision is needed by Tuesday 24 June 2025. Councillors agreed to delegate the response to the Planning & Development Working Group.

Action: Chair to corroborate the changes advised by the officer and liaise with the P&D WG to agree the council's response with the choice being to either 'agree to disagree' or 'request the LPA to refer the matter to planning committee'

# 029/2025 Councillors Report

A Cllrs Peter Luck & Steve Roberts

Cllr Luck reported that the Community Speedwatch Group had recruited four new members from Merrymeet. Following a recent CSW operation in Menheniot village centre, he recorded his continuing concerns about pedestrian safety and parking around the East Road school entrance: he explained that the Pensilva CSW group had been able to reinstate yellow road markings by their school because of local concerns about road safety.

Chair agreed to fund the purchase of four hi-viz jackets for the new volunteers.

Cllr Roberts continued the discussion about safety by the primary school, that: this issue had been long running for many months; CC Highways insisted that consultation with residents was essential before additional yellow road markings could be installed; this council wants – as a minimum – worn road marking reinstated; our PCSO Steve Edser may be able to add weight to our arguments to introduce more yellow lines and a 'no parking' zone adjacent to the school entrance. Will also investigate options for yellow lines at the bottom of Mine Hill.

It was **Resolved to support the proposal to make application** for old markings to be repainted, for additional double yellow lines and a no parking zone to be introduced. Proposed Cllr Cole. Seconded Cllr Roberts. All agreed.

Action: Cllr Robets to contact CC Highways to coordinate our response

#### B Cllr Keith Goldsmith

Trelawny Garden

Cllr Goldsmith presented his case for replacing the footpaths in Trelawny Garden that: the area to be resurfaced would include the stone circle; he planned to make an application for funding to the National Gardens Scheme that would be open to bids from September; would draw up a specification for the works.

Action: Cllr Goldsmith will work with the Finance & General Purposes Working Group to agree the specification for works and the funding application. This will be presented at the 17 July public meeting for sign-off.

#### Preparatioon for Village in Bloom

Councillors discussed preparations for the RHS (Village in Bloom) visit on 10 July, and agreed to accept a quotation from ACE-ARB of £175 for work at the village green to remove debris and reline the raised beds; Hebe removal from raised planter £25.00; Weeding of pavement that runs adjacent to Trelawney garden £55.00. **Resolved to accept the quotation**. Proposed Cllr Cole. Seconded Cllr Goldsmith. All agreed.

Action: Clerk to issue purchase order and instructions to contractor.

#### Living Willow Garden – for information

Cllr Goldsmith explained that he had created this garden in 2015 as part of a wider funding bid, and had maintained it himself since then. The land is not owned by the parish council and lies adjacent to the cricket pitch. ACE-ARB have quoted a total of £555 to prune and reinstate the garden, to include pressure washing of two benches inside. Costs will be met by donations from the Menheniot-Looe Cricket Club, Menheniot Sports Association and Cornwall Cllr Sean Smith. *Action: Chair has asked the Environment & Open Spaces Working Group to examine this project work in the longer term to determine if the parish council should be involved in funding its maintenance.* 

#### Additional works

Councillors noted that they would not ordinarily maintain land and grounds that were in private ownership. However, because of the RHS visit, they would consider small scale projects to prepare the parish for judging.

Action: Clerk to circulate recent quotations for agreement and action their decision by delegated powers.

Cllr Easterbrook left the meeting room at 21.00
